Telecast of movies on National Network

*26. DR. RANBIR SINGH: SHRI RAMNATH KOVIND:

Opening of office of RBI in Durgapur

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI M. V. CHANDRASHEKHAR MURTHY):

- (a) Reserve Bank of India (RBI) has intimated that though there was a proposal in 1982/83 to open a Sub-Office of the Calcutta Issue Department at Durgapur there was no commitment to open a second fullfledged office.
