## Refusal to accept Bharat Ratna Award for Netaji

3889. SHRIMATI KAMLA SINHA: Will the Minister of HOME AFFAIRS be pleased to state;

- (a) whether it is a fact that all the relatives of Netaji Subhash Chandra Bose refused to accept the award of Bharat Ratna announced to him, considering it as not a worthy honour for such a great revolutionary; and
- (b) if so, whether Government propose to withdraw the award and to accord a different kind of national recognition befitting his unique revolutionary role in the freedom struggle?
