C Sardesh-Pande, Since retired who had served in the IPKF had returned to the Army HQrs, in April 1990 his Uttam Yuddh Seva Medal which was conferred on him in January 1989, He did this in the context of the criticism in Tamil Nadu of the role of the IPKF in Sri Lanka. Since there is no provision for returning of such awards, the medal was handed back to the General Officer.
