- (iv) Conduct of special operations;
- (v) Up-gradation of intelligence net-work;
- (vi) Augmentation of strength for patroling/naka duties;
- (vii) Erection of border fencing and construction of border roads;
- (viii) Modernization of BSF and other police force;
- (ix) Erection of flood lights on the border to day light the area during hours of darkness; and
- (x) Establishment of new BOPs to reduce inter BOP gaps.

Traffic management in metro cities

- 224. SHRIMATI JAYA BACHCHAN: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether it is a fact that despite a number of fly-overs constructed in metro cities, the traffic management has not improved so far; and
- (b) the steps Government propose to take to improve traffic management in these metros?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI SRIPRAKASH JAISWAL): (a) and (b) Traffic management,-being a State subject, is taken care of by the respective States and no data in that regard is maintained centrally. In so far as Delhi is concerned, traffic management has shown improvement after construction of fly-overs. For smooth flow of traffic, besides posting police personnel on roads, enforcement of traffic regulation through special drives, conduct of educational and traffic awareness programmes amongst road users, coordination with other concerned agencies etc. are undertaken by Delhi Police.
