THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) to (c) No ban on recruitment to ministerial cadres as such, was imposed in 1962. However, in order to facilitate the redeployment, through the Central (Surplus Staff) Cell set up in the Ministry of Home Affairs, of the surplus staff identified as a result of the studies carried out by the Department of Administrative Reforms and the Staff Inspection Unit of the Ministry of Finance, certain restrictions have been imposed since 1966 on filling ministerial nongazetted posts, whether by promotion or direct recruitment, unless a certificate is obtained from the Cell that it has no suitable candidates to offer. These restrictions do not, however, apply to recruitment to ministerial through normal channels like the annual competitive examinations held by the Union Public Service Commission,

RE-DEVELOPMENT OF GOLE MARKET AREA

- \*731. CHAUDHARY A. MOHAM-MAD: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether it is a fact that the old municipal shops at Gole Market, New Delhi have outlived their lives, and are to be dismantled for re-development of the area under the Master Plan in due course;

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) The shops have to be dismantled under the development plans of the D.I.Z. area, but at the moment are quite safe.

- (b) Municipal shops Nos. 39 to 46 were allotted through public auction for General Merchant Stores about 30 years ago and are continuing as such.
- (c) The allottee of Shop No. 42 has requested permission to install a flour and oil mill and the case is under examination by the N.D.M.C.
- (d) Objections have been received from certain other shop-holders against this petition and they are under examination.
