THE MINISTER OF AGRO AND RURAL INDUSTRIES (SHRI KARIYA MUNDA): (a) No scheme for village industry in Chhattisgarh State is pending with the Government.

(b) The Government does not provide any funds directly to States for the development of Village Industries. The Government provides financial assistance in the form of margin money assistance under Rural Employment Generation Programme (REGP) to the Khadi and Village Industries Commission (KVIC) for the development of village industries. These funds are released on the basis of requirement. The disbursement made by KVIC to States including Chhattisgarh under REGP scheme during last three years is given in the Statement.
