Will the Minister of COMMUNICATIONS AND INFORMATION TECHNOLOGY be pleased to state:

(a) whether it is a fact that the expansion of Information Technology industry has not been the same in all the States of the country during past years;

(b) if so, the percentage of the expansion of Information Technology industry in each State during the last three years; and

(c) the turnover of the said industry during 2001-2002 in each state?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (DR. SANJAY PASWAN): (a) to (c) Yes Sir. The growth of IT industry varies from State to State. The figures for expansion of IT industry in each State are not available. However, the units in various Software Technology Parks (STPs) accounts for sizeable IT turnover. The State-wise number of units registered with various STPs and their export turnover during last three years are given in the Statemen.
