THE MINISTER OF STATE IN THE MINISTRY OF ROAD TRANSPORT AND HIGHWAYS [MAJ. GEN. (RETD.) B.C. KHANDURI]: (a) Yes, Sir.

(b) and (c) As per Ministry's guidelines, Railway, Over Bridges (ROBs) are provided to replace the exisitng level crossings if the product of Average Daily Traffic (fast vehicles only) and the number of gate closures per day exceeds 50,000 in the design year. Out of the 66 numbers of level crossings on National Highways in Andhra Pradesh, 32 do not qualify for replacement by ROBs since they do not meet the above guidelines of the Ministry.

Replacement of 28 numbers of level crossings on National Highway No. 5 and 7 by ROBs is being done under National Highways Development Project (NHDP). Of the remaining 6 provision for Land Acquisition for 3 ROBs is included in the Annual Plan 2002-03. The remaining 3 will be taken up in phases subject to inter-se-priority and availability of funds.
