amongst the youth. However, in order to prioritize sports disciplines for special focus and work out a differential pattern of assistance based on their status and performance, various sports disciplines have been identified in the following three categories:

- (i) Priority Category
- (ii) General Category
- (iii) Other Category,

However, Govt, of India through various promotional schemes of Sports Authority of India augments the efforts of the State Government in promotion of sports at sub-junior, junior and senior levels. For promotion of sports, children in the age group of 8—14 years are identified and admitted in the National Sports Talent Contest (NSTC) scheme and also Army Boys Sports Company (ABSC) scheme. Talented juniors in the age group of 14—21 years are admitted in SAI Training Centres and Special Area Games Centres of Sports Authority of India.
