- THE MINISTER OF STATE IN THE MINISTRY OF WATER RESOURCES (SHRIMATI BIJOYA CHAKRAVARTY): (a) Yes, Sir.
- (b)The Monitoring Committee of the Cauvery River Authority have held four meetings on 6.9.2001,28.12.2001,12.2.2002 and 17.5.2002 in the last one year.
- (c) to (e) Irrigation being a State subject, providing alternative employment to the unemployed agricultural workers in Cauvery River Delta districts of Tamil Nadu is the responsibility of the State of Tamil Nadu.

Irrigation projects as national projects

Repair of irrigation projects and dams in Kerala

- (a) whether Government are aware that certain major irrigation projects and dams of Kerala are in need of urgent repairs and the State Government of Kerala has requested for Central assistance;
- (b) whether Government have extended any assistance to Kerala for undertaking such repairs; and

(c) if so, the details thereof and if not, whether Government would consider to extend financial help to the State of Kerala?

- (c) Irrigation being a State subject, the planning, funding and execution of irrigation projects including repairs is done by the State Governments themselves.

Completion of irrigation projects in Chhattisgarh

- (a) the names of irrigation projects in Chhattisgarh which are lying incomplete;
- (b) the dates of commencement of these projects and the targets fixed for their completion;
 - (c) the reasons for delay in completing the projects;
- (d) the original cost of these projects and the actual estimated cost at the time of completion; and
- (e) the district-wise names of irrigation projects likely to be completed in Chhattisgarh during the Ninth Plan period?

THE MINISTER OF STATE IN THE MINISTRY OF WATER RESOURCES (SHRIMATI BIJOYA CHAKRAVARTY): (a) to (e)The details of major and medium irrigation projects of Chhattisgarh are given in the Statement (Seebelow).

The main reasons for delay in completion of these irrigation projects include thin spreading of resources by taking up too many irrigation schemes without focusing on their completion, resettlement & rehabilitation of project affected families, land acquisition problem, contractual disputes and litigation, completion of head works first without constructing the distribution system, etc.
