(b) if so, whether there are prospects of exporting ten million tonnes of wheat during 2002-2003;

(c) whether this has greatly affected the US chances of exporting wheat;

(d) if so, whether the countries like Indonesia, Malaysia, Philippines, South Korea, Sri Lanka, Vietnam and West Asia have given preference to the Indian wheat than the US; and

(e) if so, what are the efforts being made to export more wheat to these countries?

THE MINISTER OF STATE IN THE MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (SHRI U.V. KRISHNAM RAJU): (a) Yes, Sir.

(b) and (c) It is not possible to assess the prospects of exporting wheat during 2002-03 as the same would be a function of various factors including the international demand and supply situation. For the same reasons, it is also not possible to assess the impact this would have on US's chances of exporting wheat.

(d) Wheat has been exported from India to Indonesia, Malaysia, Philippines, South Korea, Sri Lanka, Vietnam and West Asia. Information about US wheat exports to these countries is not available.

(e) Wheat is not being directly exported by the Government of India. It has authorised the Food Corporation of India (FCI) to offer wheat from the Central Pool to interested parties for the purpose of export. The quantitative restrictions on the export of wheat have been lifted.

#### **FDI in food sector**

THE MINISTER OF STATE IN THE MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (SHRI U.V. KRISHNAM-RAJU): (a) No, Sir.

(b) Does not arise.

(c) Under the National Policy on Handling, Storage and Transportation of Foodgrains, approved by the Government, Foreign Direct Investment (FDI) is allowed for developing and operating bulk grain handling, storage and transportation facilities in the country.

(b) Figures are not maintained by the Central Government.

(c) Reports received from the State Governments/UTs indicate that the provisions of PDS (Control) Order, 2001 have benefited the card holders under the TPDS.
