Nursery Teachers

(a) whether it is a fact that nursery teachers have to teach nursery, 1st and 2nd standard Classes in schools, as per the provisions in the scheme/policy of Education;

(b) if so, whether directions/guidelines to States/UTs have been issued/notified for their implementation in this regard; and

(c) if so, the details thereof and if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DR. (SHRIMATI) RITA VERMA): (a) to (c) The National Council for Teacher Education (NCTE) has prescribed the minimum qualification for teaching in Class I onwards through Determination of Minimum Qualification for Recruitment of Teachers in Schools Regulations, 2001. As per these Regulations, the academic and professional qualifications for recruitment of teachers for imparting education at primary level i.e. classes 1 to 5 are (i) Senior Secondary School Certificate or Intermediate or its equivalent and (ii) Diploma or Certificate in basic teachers training of a duration of not less than two years or Bachelor of Elementary Education (B.El.Ed).

Pending this review, proposals are being examined on case by case basis. Two proposals have been received recently of which one is in advanced stage of finalization and the other is under process.
