Decline in BPL population

(b) the amount that Government spent every year for the last three years for the poverty alleviation programme and the names of the programmes which currently are being implemented; and

(c) the States which require maximum share from the total budgetary allocation for the poverty alleviation?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT AND POVERTY ALLEVIATION (SHRIO. RAJAGOPAL):
 (a) Yes, Sir. Planning Commission in their latest estimates (1999-2000) have indicated a decrease of 9.9% in the poverty ratio in the country as compared to that of 1993-94.

(b) The Ministry of Urban Development and Poverty Alleviation has been implementing through the State Governments/UTs, Centrally Sponsored Urban Poverty Alleviation Programme named Swarna Jayanti Shahari RozgarYojana (SJSRY), with effect from 1st December 1997. The details of Central funds released to States/UTs under SJSRY are as under:—
