MURLI MANOHAR JOSHI) : (a) to (c) As informed by KVS, the Government of Himachal Pradesh had recommended opening of Kendriya Vidyalayas in the districts of Mandi, Kullu, Bilaspur and Una among others in relaxation of norms applicable for opening of Kendriya Vidyalayas which could not be considered by the KVS due to the non fulfillment of the norms. However, in the academic session 2002-2003, one Kendriya Vidyalaya at Sainj, NHPC, Parbati Project, Kullu in Project Sector has been sanctioned.

National Commission forWomen (NCW) has been organising seminars, workshops, conferences, public hearing etc. on various issues concerning women, including dowry and bringing out publicity material on dowry. The Media Units of Ministry of Information & Broadcasting have also been putting up programmes for projecting positive image of women. In the Women's Empowerment Year 2001, some States had organised special awareness campaigns on women related issues, including on theevils of dowry. The Government has constituted a Task Force to review the laws concerning women, including the Dowry Prohibition Act, 1961.
