THE MINISTER OF DEFENCE (SHRI GEORGE FERNANDES: (a) No, Sir. Spares supplied to LAF by HAL have to pass through quality control checks by Directorate General of Aeronautical Quality Assurance (DGAQA), and only after their certification, the supplies are affected.

(b) Does not arise in view of reply to Part (a) above.

(c) and (d) Yes, Sir, Hindustan Aeronautics Limited (HAL) is authorised by the Russians to export MIG-21 aircraft spares manufactured indigenously or imported from Russia, to 17 countries including Algeria and Vietnam.

(e) All spares acquired by the IAF for MIG-21 aircraft are of specified quality, duly inspected and cleared by DGAQA.

**Providing drinking water to all by 2004**

DR. T. SUBBARAMIREDDY:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

(a) whether it is a fact that the Ministry has spent over Rs. 32,000 crores on the various rural water supply programmes so far;

(b) if so, whether more than 20,000 villages across the country are still without drinking water;

(c) whether Government's target for providing drinking water to all the villages by 2004 is not reachable at this speed;

(d) if so, the reasons for delay in implementing this scheme; and

(e) the steps being taken by Government to implement the scheme for providing drinking water to all by 2004?

THE MINISTER OF RURAL DEVELOPMENT (SHRI SHANTA KUMAR): (a) Yes, Sir.

(b) As per information received from the State Governments till 10-7-2002, out of the 1422664 rural habitations in the country 1274149 have been fully covered (FC) and 132183 have been partially covered (PC) and 16332 Not Covered (NC) with drinking water facilities.

(c) No, Sir.

(d) Does not arise.

(e) Rural Water Supply being the State subject, the schemes for providing drinking water supply in rural areas are planned, sanctioned and implemented by the State Governments. The Central Government supplements the efforts of the States by providing funds under the Accelerated Rural Water Supply Programme (ARWSP). As per the National Agenda of Governance all the rural habitations in the country are to be covered with drinking water facilities by 2004. It is proposed to cover most of the remaining 16332 Not Covered (NC) habitations and about half of the remaining partially covered habitations during the current financial year and the remaining habitations will be covered during the year 2003-2004. The State Governments have been requested to concentrate on coverage of all the Not Covered and Partially Covered habitations on priority basis by 2004. State-wise details of Fully Covered, Partially Covered and Not Covered habitations are given in the Statement. (*See below*) To accelerate the coverage of Not Covered and Partially Covered habitations by 2004, Government of India has recently decided to improve the weightage for NC and PC for Inter State allocations criteria under ARWSP. The weightage for Not Covered and partially Covered habitations has recently been increased from 10% to 15% in the criteria for allocation of funds under Accelerated Rural Water Supply Programme (ARWSP). This will provide adequate funds to the State Governments for providing drinking water facilities in NC and PC habitations.
