If Pakistan is serious about implementing its commitment to stop infiltration and cross border terrorism and is desirous of proving the seriousness of its intentions, joint patrolling offers a possible mechanism for verifying Pakistan's seriousness to its stated commitment. PM has in this framework offered the proposal during the CICA Summit in Almaty.

Raksha Mantri's comments had indicated that joint patrolling was not feasible if Pakistan was not serious or willing, but India was prepared to work on it.

THE MINISTER OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (SHRI SHARAD YADAV) : (a) Bureau of Indian Standards (BIS) has granted licence to use BIS Certification Mark in respect of 468 manufacturing units for Packaged Drinking Water conforming of Indian Standards 14543 : 1998, Besides, BIS has granted licence to 6 other units for Natural Mineral Water conforming to Indian Standards 13428 : 1998. Statewise distribution of the licensees is given in Statement (See below). Information regarding bottling capacity is under collection.

(b) Government has no information regarding sub-standard quality of bottled water.

(c) Does not arise.

#### Ambulance services for animals in distress

\*77. DR. ARUN KUMAR SARMA : Will the PRIME MINISTER be pleased to state :

(a) whether Government have introduced a scheme for provision of ambulance services to animals in distress;

(b) if so, the details thereof; and

(c) the State-wise number of ambulances sanctioned and provided during the last three years indicating the agency to which those were provided ?

THE MINISTER OF ENVIRONMENT AND FORESTS (SHRI T. R. BAALU) : (a) and (b) Yes, Sir. The basic objective of the Scheme is to make available emergency ambulance services to animals in distress throughout the country by provision of appropriate assistance to competent governmental and non-governmental organisations working in the field. Under the scheme 90% of the cost is borne by the Central Government upto a maximum of Rs. 3.50 lakhs.
