### SHRI PRASANTA CHATTERJEE:

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether Government are aware of the fact that the root cause of terrorism world-wide is the U.S. foreign policy that encouraged terrorism through "war and genocide" it had waged in different parts of the world; and
- (b) if so, the rationale behind India seeking in U.S. help since the U.S. has always titled towards Pakistan?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI DIGVIJAY SINGH): (a) Government unequivocally condemns and opposes all acts, methods, and practices of terrorism as criminal and unjustifiable, wherever and by whoever committed, and whatever be the reason invoked to justify terrorism.

(b) India and the United States have ongoing cooperation in combating terrorism, institutionalised through a Joint Working Group on Counterterrorism. The two Governments are committed to preventing acts of terrorism and neutralising terrorist organisations everywhere in the world.

The United States has prescribed Pakistan-based terrorist organisations such as Lashkar-e-Toiba, Jaish-e-Mohammed and Harkat-ul-Mujahideen under its domestic law; asked President Musharraf of Pakistan to crack down on terrorist organisations operating from Pakistan and Pakistan-occupied Kashmir; end cross-border infiltration into India immediately and permanently; and take action against terrorist camps in pakistan and pakistan-occupied Kashmir.
