(d) In order to prevent and control HIV/AIDS, a comprehensive Programme is currently under implementation throughout the country as a centrally sponsored scheme. The main components consist of:—

- * Reducing the spread of HIV in groups at high risk by identification of target populations and providing peer counselling, condom promotion, and treatment of sexually transmitted infections.
- * Preventive intervention for the general population by Information, Education and Communications (IEC) and awareness compaign,

provision of voluntary testing and counselling, safe blood transfusion services and prevention of occupational exposure.

- * Providing financial assistance for opportunistic infections, home and community based care.
- * Strengthening effectiveness and technical managerial, financial sustainability at National, State and Municipal levels.
- * Promoting collaboration amongst public, private and voluntary sectors.
