Surface water for drinking purpose

586. SHRI PRASANTA CHATTERJEE: Will the Minister of URBAN DEVELOPMENT AND POVERTY ALLEVIATION be pleased to state:

(a) whether the metropolitan cities are covered with 100 per cent surface water for drinking purpose; and

(b) if not, the time frame to cover such facilities in the metropolitan cities?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT AND PVERTY ALLEVIATION (SHRI O. RAJAGOPAL):
(a) and (b) A study report published by the Central Pollution Control Board (CPCB) in 1997, with regard to the status of water supply in 23 metropolitan cities of the country (based on 1991 census) had assessed that the surface water is the major source for the organised water supply in metro cities. As per the said report, 10796.2 mid of surface water and 1,941.6 mid of ground water is being used in the said metro cities.

Water supply being a State subject, it is the responsibility of the State Governments and the concerned Metropolitan cities to plan design implement, operate and maintain water supply schemes. Since the provision of surface water would depend upon technical feasibility as well

as resource availability, it would be difficult to indicate a suitable time frame.
