THE MINISTER OF INFORMATION AND BROADCASTING (SHRIMATI SUSHMA SWARAJ): (a) prasar Bharati has informed that some areas of Chhattisgarh are at present not covered by Doordarshan transmission in terrestrial mode.

(b) and (c) A Low Power Transmitter (LPT) is being installed at Pandaria, and the interim High Power Transmitter (HPT) at Ambikapur is being upgraded from 1 KWto 10 KW. Installation of Low Power Transmitter at Pandaria is nearing completion. Foundation of 150 M towers at Ambikapur has been completed and erection work is being taken up.

Fall in revenue of DD

(a) whether the revenue of Doordarshan has fallen in the last three years;

(b) if so, the details thereof; and

THE MINISTER OF INFORMATION AND BROADCASTING (SHRIMATI SUSHMA SWARAJ): (a) and (b) the gross Commercial revenue earned by Doordarshan during the last three years is as under:

1999-2000 Rs. 597.19 crores

2000-2001 Rs. 637.51 crores

2001-2002 Rs. 615.21 crores

It will be seen that the drop in revenue in 2001 -2002, is marginal.

(c) Prasar Bharati has intimated that within the constraints of a Public Service Broadcaster, Prasar Bharati endeavours to maximise its commercial revenue.
