THE MINISTER OF STATE IN THE MINISTRY OF CIVIL AVIATION (SHRI SHRIPAD YESSO NAIK): (a) to (d) The Aircraft Evaluation Committee of Indian Airlines submitted its techno-economic evaluation report to the Board Sub-Committee. The report was deliberated upon by the Board Sub-Committee. Based on the recommendations of Board Sub-\* Committee, the Board of Directors of Indian Airlines in its meeting held on 27.3.2002 have approved a proposal for acquisition of 43 aircraft *i.e.* 19A-319,4 A-320 and 20 A-321 aircraft installed with CFM-56 engines at a net project cost of Rs. 10,089 crores. The Project Report submitted by Indian Airlines is under active consideration of the Government.

## Daily flights on Delhi-Guwahati route

- 603. DR. ARUN KUMAR SARMA: Will the Minister of CIVIL AVIATION be pleased to state:
- (a) whether Government will ensure introduction of a daily morning and evening flight to and from Guwahati to connect national capital with the North-East Region legitimately instead of keeping almost all flights at a time after 10 a.m. and before 4 p.m.; and
  - (b) if so, by when?

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL AVIATION (SHRI SHRIPAD YESSO NAIK): (a) and (b) Due to aircraft and scheduling constraints and commitment on its routes network, it is presently not feasible for Indian Airlines to provide more services between Delhi and Guwahati.

## **Induction of mini-planes**

- 604. SHRI SUDARSHAN AKARAPU: Will the Minister of CIVIL AVIATION be pleased to state:
  - (a) whether Indian Airlines propose to induct mini-planes; and
- (b) if so, the number to be added and how the investment amount would be arranged?

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL AVIATION (SHRI SHRIPAD YESSO NAIK): (a) and (b)The proposal of Indian Airlines for purchase of six 50 seater ATR 42-500 aircraft was considered by the

Government in June, 1999. However, the proposal was not found viable. Therefore, the Government advised Indian Airlines to explore the possibility of acquiring these aircraft on lease basis. Currently, Indian Airlines is in the process of finalizing dry-lease of ATR-42-320 aircraft.

## Insurance cover for travel agents

- 605. SHRIMATI N.R DURGA: Will the Minister of CIVIL AVIATION be pleased to state:
- (a) whether Indian Airlines propose to provide insurance cover to their travel agents;
  - (b) if so, the details thereof; and
- (c) the reasons for Indian Airlines burdening themselves for fire, burglary etc. of the office of the agents?

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL AVIATION (SHRI SHRIPAD YESSO NAIK): (a) No, Sir.

(b) and (c) Do not arise.

## Earnings of IA and Al

606. SHRI RAJNATH SINGH 'SURYA': Will the Minister of CIVIL AVIATION be pleased to state:

- (a) whether it is a fact that a large percentage of IA and Als earnings come from Government and semi-Government sources;
  - (b) if so, the percenage thereof to the total earnings;
  - (c) whether it is also a fact that these are called as official carriers; and
- (d) if so, whether there are any instructions that all Government servants use IA and Al for travelling?

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL AVIATION (SHRI SHRIPAD YESSO NAIK): (a) No, Sir.

- (c) and (d) Yes, Sir.
