(d) and (e) The Commission has already held 6 sittings at different places. 65 Affidavits have been filed and 83 witnesses have been examined so far. It is also examining a large number of articles and documents, allegedly belonging to one "Gumanami Baba" referred to in the "Asian Age" of June 11, 2002. The Commission is required to submit its report to the Central Government as soon as possible but not later than the 14th May, 2003.

Condition of Kashmir Pandits living in camps

¶810. SHRI P.K. MAHESHWARI: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that millions of Kashmiri Pandits have been staying at refugee camps at Jammu and elsewhere in pathetic condition after abandoning their homes in 1990;

(b) if so, whether they are falling prey to the number of diseases;

(c) if so, whether Government's attention has been drawn to increase in their death rate and decline in birth rate in these camps; and

(d) if so, the concrete steps Government have taken in this regard, if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI CHENNAMANENI VIDYASAGAR RAO): (a) There are 56246 Kashmiri migrant families of which 34305 families are staying in Jammu, 19338 families in Delhi and 2603 families in other States. Of these, 238 migrant families are living in 14 camps in Delhi and 4778 families in 12 camps in Jammu. Others are living under their own arrangements. As reported by State Government the condition in the migrant camps is satisfactory. All facilities including water, electricity, health, schools education and sanitation are being provided to the migrants putting up in the camps. In addition relief as per norms approved by the State Government or Union Territory is also being provided.
