

Supply of Foodgrains in NER

921. SHRI RISHANG KEISHING: Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

- (a) the States which are surplus and deficit in foodgrains production;
- (b) the production and supply figures of foodgrains in eight States of North Eastern Region including Sikkim;
- (c) the arrangement being made to meet the deficit; and
- (d) the complaint/defect on the arrangement made and the corrective measures taken, if any?

THE MINISTER OF STATE IN THE MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (SHRI U.V. KRISHNAM RAJU): (a) A Statement-I showing deficit and surplus States during the last three years is annexed. (See below)

(b) A Statement-II showing the allotment and offtake of rice and wheat during the period from April, 2001 to March, 2002 and production of foodgrains during 2001 in eight States of North Eastern Region is annexed. {See below}

(c) and (d) In order to ensure supplies of food grains in the deficit States the following arrangements are made:

(i) Allotment of food grains from Central Pool are made to the States/ UTs for distribution under TPDS and other schemes such as Antyodaya Anna Yojana, Food for Work Programmes, Mid day Meal Scheme etc.

(ii) Government resorts to open Market Sale Scheme (Domestic) of wheat and rice.

(iii) principal Distribution Centres are opened.

(iv) Arrangements for transportation of foodgrains are made.

(v) Transport Subsidy is provided.

(vi) In case, a State/UT is not able to lift the allotted food grains within the distribution period, extension is given on merits of the case on receipt of a request from the concerned State/UT.

In the case of North Eastern Region, adequate quantity of food grains have been allotted.
