THE MINISTER OF STATE IN THE MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (SHRI U.V. KRISHNAM RAJU): (a) to (c) Yes, Sir. The number of BPL families as per the Government of India estimates in Andhra Pradesh in 40.63 lakhs against which the State Government has identified 113 lakh families. The Statewise number of BPL families have been worked out as per the poverty estimates of the Planning Commission for the year 1993-94 adopting the methodology of the Expert Group applied to the population projections of the Registrar General as on 1.3.2000. This basis is being uniformly applied for allocation of foodgrains to all BPL families in the country without exception and cannot be changed for any one State in isolation.

Abolition of Essential Commodities Act
