National Highways in West Bengal

1000. SHRI PRASANTA CHATTERJEE: WillI the Minister of ROAD TRANSPORT AND HIGHWAYS be pleased to state:

- (a) whether there is any request pending from the West Bengal Government, which has international boundaries with neighbouring countries, for enlisting Highways as National Highways; and
 - (b) if so, the name of the higheways and the action taken on the request?

THE MINISTER OF STATE OF THE MINISTRY OF ROAD TRANSPORT AND HIGHWAYS [MAJ. GEN. (RETD.) B.C. KHANDURI]: (a) and (b) 13 proposals for declaration of state roads as National Highways in West Bengal had been received and have now been returned to the State Government in June, 2002 for review based on the revised criteria for declaration of new National Highways. There is no proposal to declare any new National Highway in the country at present due to fund constraints. The Government may however, consider declaration of a few State Highways as National Highways during the course of the 10th Five Year Plan from amongst the modified proposals to be received from various states keeping in view the trafic need, *inter-se* priority and availability of funds.
