At present there are no private hospitals recognized under CGHS at Bhubaneswar. In response to the tenders floated by CGHS calling for applications from private hospitals for getting recognition under CGHS Bhubaneshwar, only Kalinga Hospital had responded but it did not agree to the ceiling rates offered by CGHS for various medical procedures/tests/investigations and therefore, this hospital has not been granted recognition under CGHS.

ESI Hospitals do not ceter to CGHS beneficiaries.

Increase in Population

1235. SHRIRAJKUMAR DHOOT: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether it is a fact that the population in India is still increasing at an alarming rate;
- (b) if so, whether Government contemplate taking any harsh measures to control birth rate in the country;
 - (c) if so, the details thereof and if not the reasons therefor;
- (d) the amount of money spent for the control of population during the last three years and whether result achieved commensurate with the money spent; and
- (e) the amount of money earmarked for sterilization during current year and the number of sterilization operations anticipated?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI A. RAJA): (a) to (c) As per census 2001, the average exponential growth rate of population in the country declined to 1.93% during 1990-01 as compared to&14% during 1981-1991. The cuffent growth rate in population is contributed largely by three factors namely (r) Large population in the reproductive age (») Unmet needs of contraception and health services (iii) Felt need of higher fertility due to high 1MB, son preference etc.

In keeping with the democratic tradition of the country, the family welfare programme is voluntary in nature and depends on informed choice of family planning methods best suited to individual acceptors. Past experience shows that it is not feasible to inforce coercive measures for its promotion. Further, success of family welfare programme In Kerala, Goa and Tamil "Nadu shows that coercion Is not required for the implementation of the programme.

(d) The amount of money spent on the National Family Welfare Programme during the last three years is as follows:

The States which show better performance in family welfare, receive higher allocations in the budget depending on the performance particularly in respect of supply of contraceptives, compensation for sterilizatiOn/UD insertion and area specific programmes.

(e) The tdtal amount of money earmarked for sterilization & IUD insertion during current year is Rs. 163.50 crores. The number of sterilization operations anticipated during the current year is 491akhs.
