## Water supply to LIG flats, Manglapuri

1329. SHRIMATI GURCHARAN KAUR: Will the Minister of URBAN DEVELOPMENT AND POVERTY ALLEVIATION be pleased to state:

- (a) the details of arrangements of water supply made by Government to the residents of the LIG flats of DDA in Pocket 13 of Manglapuri, New Delhi:
- (b) whether it is a fact that the water supplied to this area is full of iodine, salt, clourine, and other dirty ingredients;
- (c) whether the water supplied to above said area is properly treated; and
- (d) if not, the reasons therefor and the steps taken by Government to supply well-treated water to the residents of that area?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT AND POVERTY ALLEVIATION (SHRI O. RAJAGOPAL): (a) to (d) The Delhi Development Authority has informed that Delhi Jal Board water is being supplied in Pocket 13 of Manglapuri, New Delhi. The water supplied in this area is potable and fit for drinking.

been implementing through the State Governments/UTs, a Centrally Sponsored Urban Poverty Alleviation Programme named Swarna Jayanti Shahari Rozgar Yojana (SJSRY), with effect from 01.12.1997. The details of budget provided, amount actually spent and unspent amount for the years 1999-2000, 2000-2001 and 2001-2002 are as under:—
