Maternal and Infant Mortality Rate

† 1226. SHRIMATI MAYA SINGH : Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) the maternal and infant mortality rate during the last two years;

(b) whether it is a fact that there has been an increase in the average maternal and infant mortality rate during these two years;

(C) if so, the details thereof; and

(d) the steps being taken by Government and State Governments with mutual cooperation to reduce the mortality rate during the next two years?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI A. RAJA): (a) to (c) As per the Sample Registration System of Registrar General of India the maternal mortality ratio* of India was 408 in 1997 and 407 in 1998. Data for subsequent years & not available. The infant mortality rate was 70 during 1999 and has declined to \$8 in 20QO.

(d) Under the Reproductive and Child Health programme, launched in the country in 1997, interventions for improving maternal and child health and reducing maternal and infant mortalities are being implemented in all districts of the country.

The interventions, for children include Immunization against six vaccine preventable diseases, control of deaths due to Diarrhoea, control of Acute Rerspiratory Infections, Prophylaxis for Vitamin A deficiency, Iron deficiency anemia and Essential Newborn Care.

For mothers the intervention include essential obstetric care; emergency obstetric care, provision of referral transport though panchayats and provision of drugs and equipment at first referral units, provision of contractual! staff like Additional Healttt Workers, staff nurses, doctors and anesthetist. Funds are also being provided for scheme like 24 hours delivery services at selected primary/health centres and community health centres.
