Contract Farming for Cotton

1601. SHRI GHULAM NABI AZAD: Will the Minister of TEXTILES be pleased to state:

(a) whether Government has decided the modalities for contract farming in cotton at the earliest to ensure adequate supply of quality cotton to the mills;

(b) if so, whether it has been suggested that the modalities for contract farming in cotton should be worked out to establish an organic linkage between the farmers and the textile mills in order to ensure adequate supply of good quality cotton to the mills;

(c) whether any norms for cotton farming has been decided upon; and

(d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF TEXTILES (SHRI BASANGOUDA R. PATIL): (a) to (d) In order to provide organic linkages between farm and industry, the Government has taken initiatives to popularize integrated cotton cultivation. This envisages availability of good quality timely inputs and technical advice to farmers as well as assured sale of their good quality cotton to industry, which would be benefited by quality raw material at competitive prices. It is a voluntary integration between farmers and industry. The role of the Government is to facilitate such integration. No specific norm for cotton fanning has been decided.
