THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI CHENNAMANENI VIDYA SAGAR RAO): (a) and (b) During the years 1999 to 2001, four employees of New Delhi Municipal Council (NDMC) were placed under suspension for cases registered against them under the Prevention of Corruption Act for the demanding and accepting illegal gratification or for entering into criminal conspiracy to cause financial loss to the Council.
