In addition, CISF personnel are deployed at selected monuments.

THE MINISTER OF STATE IN THE MINISTRY OF CULTURE (SHRIMATIKANTI SINGH): (a) The Anthropological Survey of India started an important research study scheme on 2nd October, 1985 at the National level under the leadership of Dr. Kumar Suresh Singh, which was named as 'People of India'.

(i) All the 11 "National Volumes' have been published;

(ii) Out of 32 'State Volumes', 29 State Volumes have been published;

(iii) Three Volumes on Bihar, Madhya Pradesh and Orissa will be published shortly.

(b) The number has declined in the case of Class IV employees only.

(c) to (e) All Ministries/Departments are required to review their vacancies regularly and take necessary steps in the light of such reviews. There is provision for filling up vacancies by Government Departments as per their requirements subject to extant guidelines and rules on the matter.
