- (a) whether Government's attention has been drawn to an editorial in English print media captioned "The Unending Farm Tragedy" on 2nd February, 2008; and
 - (b) if so, what are steps being taken to end this tragic phase of our agricultural history?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI KANTILAL BHURIA):(a)Yes,Sir.

(b) To address the problem of suicide by farmers, Government of India has approved a Rehabilitation Package amounting to Rs. 16978.69 crore, for 31 districts spread over the States of Andhra Pradesh, Maharashtra, Karnataka and Kerala. The Package aims at establishing a sustainable and viable farming and livelihood support system through debt relief to farmers, improved supply of institutional credit, assured irrigation facilities, watershed management, better extension and farming support services and subsidiary income opportunities.

Based on the Revised Draft National Policy for Farmers submitted by the National Commission on farmers, the Government has approved the National Policy for Farmers, 2007, Various recommendations made by the Commission for rejuvenation of agriculture and allied sectors, as accepted by the Government, have been incorporated in the National Policy for Farmers. For revitalization of agriculture sector, Government has launched two new Schemes namely, National Food Security Mission (NFSM) to improve productivity and production of foodgrains in the country and Rashtriya Krishi Vikas Yojna (RKVY) with and objective to incentivise the States so as to increase public investment in agriculture and allied sectors. Besides, a number of inititives, Plan Schemes and programmes including the initiatives/ programmes announced in the Budget 2008-09 have been taken/initiated, including a scheme of debt waiver/debt relief for farmers.

Deficiency in NFSM

798. MS. MABEL REBELLO:

PROF. M.S. SWAMINATHAN:

Will the Minister of AGRICULTURE be pleased to state:

- (a) the present status of the National Food Security Mission;
- (b) whether the small and marginal farmers are able to meet 50 per cent of the cost of implements and other inputs as stipulated in the NFSM; and
- (c) the number of small and marginal farmers who have been able to pay 50 per cent of the cost and take part in the Mission?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI KANTI LAL BHURIA): (a) to (c) The National Food Security Mission has been launched with effect from Rabi 2007-08 in 17 States of the country. Under the National Food Security Mission the beneficiaries may contribute 50% of the cost of their own or avail credit from banks for any intervention including farm implements. In such cases, the subsidy for specific component will be released to the banks from which the credit is availed. The States have been requested to earmark at least 33 per cent of the total allocation of the Mission to small and marginal farmers including women and SC and ST farmers.

Crash in price of coconut

- 799. PROF. P.J. KURIEN: Will the Minister of AGRICULTURE be pleased to state:
- (a) whether Government is aware that the coconut growers are in distress because of the crash in price of coconut;
- (b) if so, the details thereof; and
- (c) the action Government will take to ensure the remunerative price to the account growers?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRIKANTILAL BHURIA):

- (a) and (b) Wholesale prices of coconut in the country which remained depressed in 2007 have started increasing from January, 2008 onwards. As against the annual average of the Wholesale Prices Index (WPI) for Coconut fresh at 130.0 (with base 1993-94=100) for the year 2006, the average of WPI for January and February of 2008 (first three weeks) has increased to 135.3.
- (c) With a view to provide remunerative prices to coconut growers in the country, the Government has been fixing the Minimum Support Prices (MSPs) for Milling and Ball Copra on annual basis and undertaking procurement operation through the National Agricultural Cooperative Marketing Federation Ltd. (NAFED). The MSP for Milling and Ball Copra fixed for 2008 season are Rs. 3600/-and Rs. 3910/-per quintal respectively.

Further, the Government would be fixing the MSP for mature dehusked coconut from 2008 season in consultation with the State Governments, NAFED and other concerned. This is expected to provide price support directly to the coconut farmers.

Implementation of programmes under NFSM in Orissa

Will the Minister of AGRICULTURE be pleased to state:

- (a) whether in order to boost the economy of the farmers, Orissa Government proposes to implement programmes under the National Food Security Mission and the Rashtriya Krishi Vikas Yojana;
 - (b)if so, the details thereof;
- (c)whether the State Government has submitted a proposal of Rs. 850 crores to the National Food Security Mission for taking up various agricultural activities under this project; and
 - (d)if so, the details along with status thereof?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI KANTI LAL BHURIA) (a) to (d) The National Food Security Mission (NFSM) and Rashtriya Krishi Vikas Yojana (RKVY) have been launched during Rabi 2007-08 in the country including Orissa. The NFSM is implemented in selected districts while RKVY is implemented in all the districts of the State through District Agricultural Plans. NFSM-Rice and NFSM-Pulses are implemented in 15 and 10 districts of the State, respectively. For the implementation of NFSM interventions,
