## Curbing of capitation fee

## \*158. SHRI AMAR SINGH: SHRI ABU ASIM AZMI:

Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether Government has finalised any legislation to curb the capitation fee menace and also to bring transparency in admissions in private professional colleges;
  - (b) if so, the details thereof; and
  - (c) by when it would be implemented?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) to (c) As per Section 10 of the All India Council for Technical Education (AICTE) Act, 1987, duties of the Council include (i) fixing norms and standards for charging tuition and other fees, (ii) taking all necessary steps to prevent commercialization of technical education, and (iii) providing guidelines for admission of students to technical institutions. Further, as per judgment dated 14.08.2003 of the Hon'ble Supreme Court in the case of "Islamic Academy of Education and another Versus State of Karnataka and Others" and endorsed by it in its subsequent judgment dated 12th August, 2005 in "P.A. Inamdar & Ors. Versus State of Maharashtra & Ors.", each State Government is required to set up two Committees, each headed by a retired High Court Judge, to regulate (i) admission to, and (ii) fee chargeable by private professinal colleges.

## Participation in Programme of International Student Assessment

## \*159. SHRI RAHUL BAJAJ: SHRI RAJKUMAR DHOOT:

Will the THE MINISTER OF HUMAN RESOURCE DEVELOPMENT be pleased to state the reasons for not participating in OECD's Programme of International Student Assessment (PISA) for assessment of science education quality, while 67 countries including developing countries, do so?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): Programme for International Student Assessment (PISA) is an internationally standardized assessment for 15 year old students in schools and is meant for member countries of OECD along with certain partner countries. The government of India conducts its own pupil learning achievement surveys under Sarva Shiksha Abhiyan (SSA) through National Council of Educational Research and Training (NCERT) aimed to track changes in learning achievement levels of students and to give a national picture of the status of students learning levels. NCERT conducted such sample surveys for Class V in 2002-03, for Class III and Class VII/VIII in 2003-04 and for Class-V in 20-06-07. The NCERT surveys cover a representatives sample of students across districts.
