Vadodara-Mumbai Expressway

*213. SHRI KESHUBHAI S. PATEL: SHRI SURENDRA MOTILAL PATEL:

Will the Minister of SHIPPING ROAD TRANSPORT AND HIGHWAYS be pleased to state:

- (a) the progress made subsequent to the declaration in Parliament for taking up the work of Vadodara-Mumbai Expressway;
 - (b) the phases of planning and implementation;
- (c) whether it is a fact that the State Government of Gujarat had frozen land of 300~m width along the proposed alignment of Vadodara-Mumbai Expressway as back as in 1991; and

(d) if so, by when the acquisition of land would be started?

THE MINISTER OF SHIPPING, ROAD TRANSPORT AND HIGHWAYS (SHRI T.R. BALLU): (a) Subsequent to the declaration of Vadodara-Mumbai Expressway, proposals were invited from domestic as well as international consultants for comprehensive feasibility study of the Expressway including fixing of the alignment, planning of facilities, preliminary design and costing, preparation of bid documents and assistance in bidding. There was no response to the bids despite being invited twice. Further, limited enquiries were floated from some of the International Consultants working in India. Since there was no response, it was decided to split the services into smaller segments. In the first step, bids .iave been invited for fixing the expressway alignment. In the subsequent stages feasibHity studies will be taken up.

- (b) The various phases of planning and implementation are as under:-
 - (i) Fixing the alignment
 - (ii) Feasibility studies and facility planning,
 - (iii) Preparation of land plan schedules
 - (iv) Acquisition of land
 - (v) Preparation of bidding documents
 - (vi) Appraisal and approval of the project by Government,
 - (vii) Invitation of bids
 - (viii) Award of concession
 - (ix) Financial Closure
 - (x) Commencement of Expressway construction
 - (xi) Completion of the expressway and start of commercial operation.
- (c) Yes, Sir.
- (d) The land acquisition process is likely to start sometime in the middle of 2009.
