(c) to (f) The scheme covers the entire country including the State of Goa. From the State of Goa, in 2007-06 Life and Income certificates were produced by 5 beneficiaries in Central Quota and 6 in Centre-State Quota, who were sanctioned a total amount of Rs. 1,20.000/-(Rupees one lakh and twenty thousand) and Rs. 1,08,000/- (Rupees one lakh and eight thousand) respectively by the Central Government.

Angkorwat Temple as "Wonders of the World"

- 2354. SHRI SHREEGOPAL VYAS: Will the Minister of CULTURE be pleased to state:
- (a) whether it is a fact that the overseas Indians had demanded for inclusion of famous Angkorwat Temple into the wonders of the world;
- (b) whether Government intends to provide knowledge related to features to the Indian students;
- (c) the names of temples which have become famous during the last three years and the names of countries where these temples are situated; and
- (d) whether the Heads of the States of these countries participated in the inauguration thereof?

THE MINISTER OF CULTURE (SHRIMATI AMBIKA SONI): (a) to (d) A private organisation called the New 7 wonders foundation, was behind the New 7 Wonders of the world campaign and has announced 7 New Wonders of the World. Government of India was not associated with this campaign in any manner. Angkorwat Temple was one of the 21 monuments short listed by the foundation but did not find a place in the final list.
