Determining the formula of measuring poverty afresh

†2619. SHRI LALIT KISHORE CHATURVEDI: Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether it is a fact that various State Governments are demanding to determine the formula of measuring poverty afresh;
 - (b) whether the present poverty line is below the level of subsistence; and

(c) whether any discussion has been held with the Planning Commission and Ministry of Finance in this connection, if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRIMATI SURYA KANTA PATIL): (a) The Planning Commission estimates the incidence of poverty at National and State level from the large sample survey on household consumer expenditure conducted by the National Sample Survey Organisation (NSSO) following the methodology contained in the Report of the Expert Group on Estimation of Proportion and Number of Poor. No communication has been received in the Planning Commission from the States with the demand to determine the formula for measuring poverty afresh.

- (b) The poverty line used by the Planning Commission is based on a minimum level of food and non-food consumption, which is necessary for subsistence. These are estimated at the national level in rural and urban areas. The State-specific povery lines are derived from the national level poverty lines, using State-specific price indices and inter-State price differential. The State-specific poverty lines are periodically updated for price inflation using the methodology contained in the Report of the expert Group on Estimation of Proportion and Number of Poor.
- (c) No such discussion has taken place in so far as changes in the method of determination of the formula of measuring poverty by the Planning Commission are concerned.
