THE MINISTER OF STATE IN THE MINISTRY OF TEXTILES (SHRI E. V. X. S. ELANGOVAN): (a) The Government of India is following a policy of promoting and encouraging the handloom industry In the country, including the State of Andhra Pradesh through number of programmes and schemes to increase the production, productivity and efficiency and enhance the Income and socio-economic status of weavers by upgrading their skills, supply of inputs, providing infrastructure, marketing support etc.

- (b) The central assistance is released to State Governments on receipt of viable proposals. District-wise details of central assistance released is maintained by the State Government concerned. However, the Government of Andhra Pradesh has been released Rs. 1411.99 lakh. Rs. 1332.91 lakh, and Rs. 2472.06 lakh under various scheme during 2005-06, 2006-07, and 2007-08 respectively.
- (c) to (e) Government of India has been implementing various handloom schemes which are equally applicable to all States, including the State of Andhra Pradesh.

The Ministry of Textiles sanctions research projects under plan schemes such as Export Promotion Studies, Research and Development Schemes for Handicrafts, Design and Development of Jute Diversified Products and Research and Development, Training and Initiatives of Sericulture etc. to various reputed institutions.

(b) A Statement showing the list of the research projects sanctioned during the last three years is attached herewith (See below).

- (c) and (d) The research projects under the various plan schemes are sanctioned as per the procedure prescribed in the guidelines of the respective schemes. In sanctioning the various research projects, the provisions of the General Financial Rules and other guidelines issued by the Ministry of Finance are also complied with. The topics'areas of the research projects are decided on the basis of internal consultations and after assessing the relevance and utility of the area/topic of study to the functioning of the Ministry, in the case of research projects where the cost is less than Rs. 25 lakh, a list of potential consultants etc. is prepared on the basis of formal and informal enquiries and where the cost is above Rs. 25 lakh, an advertisement inviting "Expression of Interest" from consultants is published in at least one of the national dailies and on the Ministry's website.
- (e) to (g) The selection process of the consultants is based on technical and financial bids. Technical bids are analysed and evaluated by a Consultancy Evaluation Committee (CEC) of the Ministry. On the basis of the academic qualifications, quality of presentations made by the applicants etc., the agencies/consultants which secure high scores are short listed. Financial bids are open only to the technically qualified bidders. Based on the technical and financial criteria, the CEC awards the assignment for undertaking the research project to the lowest bidder.
