theft, the quantity of coal recovered and its approximate value in the Pench and Kanhan Areas of Western Coalfields Limited in the past three years are as under:

- (c) FIRs are lodged by the units/area/Central Industrial Security Froce (CISF) officials whenever cases of theft/pilferage of coal are detected. After lodging of FIRs such prosecution cases are lauched and contested by the State Government/Police where warranted.
- (d) Law and Order is a State subject. However, following steps are taken by coal companies to prevent theft/pilferage of coal and illegal mining:
 - (i) Check Posts have been established at the vulnerable points.
 - (ii) Wall fencing, light arrangements and deployment of armed guards round the clock has been done around the coal dumping yard.
 - Regular patrolling is conducted in and around the mine including Over Burdon (iii) (OB) dumps.
 - (iv) Regular FIRs are lodged by the Mangement of the collieries with local Thana against the pilferage/theft of coal.
 - (v) 125 CISF personnel have been deployed in Pench Area w.e.f. 16.10.2007 and efforts are on to deploy remaining 231 CISF personnel at in the Area.
 - (vi) Joint survey by CISF officials and Wstern Coalfields Limited officials has been carried out on 24th, 25th and 26th March, 2008 for deployment of CISF at Kanhan Area of the company.

- (a) the steps taken to provide appropriate services to senior citizens and women in metropolitan Delhi;
- (b) the number of complaints received from them for not getting suitable services during the current year and the action taken thereto; and
- (c) arrangements to be made to provide appropriate services to senior citizens and the women consumers?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (SHRI JYOTIRADITYA MADHAVRAO SCINDIA):

(a) and (c) The following steps are taken in Mahanagar Telephone Nigam Limited (MTNL), Delhi and Department of Posts to provide services to senior citizen and women consumers:—

Mahanagar Telephone Nigam Limited (MTNL), Delhi

- * There are separate queues at customer service centers for senior citizen and women consumers for depositing their bills and attending to other queries. Seating arrangements have been made to the extent possible.
- * 25% rebate in installation charges for landline connection is given to senior citizens. 25% rebate in monthly rental charges is also given to senior citizens in the Tariff Plan-250, against one landline connection.
- * All employees of customer service centers have been advised to attend senior citizens and women consumers for their specific needs if possible.

Department of Posts

- Separate counters/queues for senior citizens and women customers have been provided wherever feasible. Seating arrangements have been made to the extent possible.
- Best efforts are made to provide facilities on the suggestions received from senior citizens and women.
- (b) In MTNL, Delhi; 52 Nos. of complaints were received from senior citizens and women during 2007-08 and their problems were solved promptly to their satisfaction.

In Department of Post, no complaint has been received in 2008 from senior citizens and women.

Spectrum allocation criteria

- 2644. SHRI JESUDASU SEELAM: Will the Minister of COMMUNICATIONS AND INFORMATION TECHNOLOGY be pleased to state:
- (a) whether in a bid to arrive at a compromise formula with agitated GSM operators, the Communication Ministry formed a new Committee to revive the subscribe linked spectrum allocation criteria specified by the Telecom Engineering Centre;
- (b) whether the Telecome Engineering Centre-the technical wing of the DOT formed a team of 4 or 5 officers which would visit the network of dominant operations such as US, UK, Japan, France and South Korea;
- (c) whether any final decision for allotting spectrum has been considered by the Government; and
 - (d) by what time final decision in this regard is likely to be taken?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (SHRI JYOTIRADITYA MADHAVRAO SCINDIA): (a) The Government, during November 2007, consitituted a Committee with academia, representatives from industry and Government, to recommend revised subscriber based spectrum allocation criteria. The Committee in its report has recommended allocation of additional spectrum in steps of 1 MHz.
