Action Plan to improve the condition of working children

†2141 SHRI JANESHWAR MISHRA: Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether it is a fact that children of the country are forced to live by working as labourers in their age of study and sports:
- (b) if so, whether Government is formulating any action plan to improve the condition of such children: and
 - (c) if so, the State-wise details of the number thereof?

THE MINISTER OF STATE OF THE MINISTRY OF LABOUR AND EMPLOYMENT (SHRI OSCAR FERNANDES): (a) and (b) Child Labour is a complex socio-economic problem, which needs sustained efforts over a long period of time. Considering the nature and magnitude of the problem, government is following a sequential approach of first covering children working in hazardous occupations/processes. The National Plan of action for elimination of child labour includes project based plan of action covering families of child labour in general development programmes and strict enforcement of the Child Labour (Prohibition and Regulation) Act, 1986. Government is implementing the National Child Labour Project (NCLP) Scheme in 250 districts of the country. Under the Scheme, children withdrawn from identified hazardous work are put into Special Schools, where they are provided with accelerated bridging education, vocational training, nutrition, stipend and health care facilities etc., before they are mainstreamed into regular education system.

(c) The State-wise number of child labour as per Census 2001 is enclosed as statement.

New guidelines on scheduled rate for paying wages under NREGS

 - (b) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI CHANDRA SEKHAR SAHU): (a) and (b) Yes, Sir. Union Government has issued clarifications to all States that Schedule of Rates (SORs) of various executing agencies for similar nature of activities and out puts in the same area must be same. States have also been asked to get these SORs notified by the competent authority of the State as SORs would have horizontal application across the departments/agencies.
