sector or in the handloom sector, or making pickles, papad, vadies, etc., otherwise, these things which were supposed to be their domain, even these will be taken away from them. Consequently, the multinationals will come and will make money for themselves. I appeal to you, hon. Minister, to look favourably into these things. Thank you, Sir.

THE VICE-CHAIRMAN (SHRI SURESH PACHOUR!): The discussion on this Resolution will continue on 16<sup>th</sup> March, 2001. Now, there is one message from the Lok Sabha.

"I am directed to inform you that the Judicial Administration Laws (Repeal) Bill, 2000, which was passed by Rajya Sabha at its sitting held on the 29<sup>th</sup> November, 2000, has been passed by Lok Sabha at its sitting held on the 2<sup>nd</sup> March, 2001, with the following amendments:-

## Enacting Formula

- Page 1, line 1, for "Fifty-first"
   substitute "Fifty-second"
- 2. Page 1, line 4,
  For "2000"

  Substitute "2001"

I am, therefore, to return herewith the said Bill in accordance with the provisions of rule 121 of the Rules of Procedure and Conduct of Business in Lok Sabha with the request that the concurrence of Rajya Sabha in the said amendments be communicated to Lok Sabha."
