(a) the details of Central Schools opened in Arunachal Pradesh during the last three years;

(b) the details of Central Schools to be established in the State during the next two years;

(c) the details of budgetary provisions made by Government for the purpose during the Ninth Five Year Plan; and

(d) what steps are being taken by Government in this regard?

(a) Only two Kendriya Vidyalayas were opened at Along and Kimin in Arunachal Pradesh during the year 1996-97.

(b) There is no proposal for establishing new Kendriya Vidyalaya in the State of Arunachal Pradesh.
