- (b) if so, Government's reaction thereto;
- (c) whether National Human Rights Commission has also drawn up any outline of the proposed Indian Jail bill; and
  - (d) if so, the complete details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI CH. VIDYASAGAR RAO): (a) and (b) The National Human Rights Commission (NHRC) in its Annual Report for the years 1996-97 and 1997-98 had expressed its concern about the condition prevailing in the jails and had also observed that there is need for the replacement of the Indian Prison Act of 1894. The Annual Reports of the Commission alongwith the Action Taken Memorandum have been laid on the table of Lok Sabha.

(d) ©and (d) Yes, Sir. The outline of the new Prison Bill drawn up by NHRC lays emphasis on a thorough reorganisation of prison system to bring it in tune with the modrern criminology and penological thinking so as to cater to the changed and changing environment of the society' in transition.

## **Tibetan Demonstration in Capital**

- (a) whether the effigy of Chinese President alongwith China's flag was burnt by the lady Tibetan demonstrators recently in New Delhi on the 41 st Lady Rebellion Day;
  - (b) if so, the details thereof;
  - (c) the number of Tibetan ladies arrested in this regard; and
  - (d) the action taken against those ladies?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI CH. VIDYASAGAR RAO): (a) to (d) On 12 March, 2000 a group of Tibetan women held a demonstration at Parliament Street, New Delhi and burnt the effigy of the Chinese President alongwith 41 pieces of red cloth. Sixty

women demonstrators were detained by Delhi Police under section 65 of the Delhi Police Act. 1978 and were subsequently released.

## **Modernisation of Metro Police Forces**

- 3991. SHRI BHAGATRAM MANHAR: Will the Minister of HOME AFFAIRS be pleased to state
- (a) Whether Government are considering a proposal to modernise police force in the mctros of all States;
  - (b) if so. the details thereof,
- (c) whether Government propose to acquire modern and sophisticated equipments for the police force in various State capitals; and
- (d) if so, the details of such equipments likely to be purchased during the never two years and the budget earmarked for such equipments?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI I.D. SWAMI): (a) to (d) 'Police' is a State subject as per the Constitution of India. As such, it is primarily the responsibility of the State Governments to modernise their police forces, including those deployed in Metro cities. However, to supplement the efforts of the State Governments in this regard, the Central Go\ ernment has been providing financial assistance to the State Governments through the awards of the Finance Commission as well as under the Scheme for Modernisation of State Police Forces. An amount of Rs. 200 crores is available under the Scheme for Modernisation of State Police Forces during the current >ear 2000-2001. The same amount is proposed to be provided for the next year. i.e.. 2001-2002.

The Central Government is also implementing, with effect from the financial year 1997/98. a special scheme for Modernisation of State Police Forces in the North-East under which arms and ammunitions, vehicles and communication and other equipment are provided in kind. The expenditure incurred under this Scheme last year. *i.e.*. during 1999-2000 was Rs. 50.87 crores approximately.
