The Small and Cottage industries constitute more than 50% of industrial employment.

- (b) Promotion of small and cottage industries for increasing the employment opportunities is one of the accepted policies of the government. Government has been running a large number of schemes for promotion of SSI sector, these include technology upgradation, market development, infrastructure development, entrepreneurship development, and dissemination of information. Credit to SSI sector has been facilitated by incresing collateral free loans limits and enhancing the limit of composite loan through single window. A Credit Guarantee Scheme is being started to gruarantee loan upto Rs. 10 lakh to remove the problem of collaterals for small and cottage industries.
- (c) Total number of units of small scale industries was 30.14 lakh which includes 23.52 lakh registered SSI units as on 31.3.1998. As on 31.3.1998 there were 4969 institutions registered directly with the KVIC and 30129 cooperative societies and 784981 individual units registered with KVI Boards. Number of Coir units registered with the Coir Board was 7259 as on 31.3.1998.

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SHRI OMAR ABDULLAH): (a) Statement indicating amount released to each state (for spending on training, entrepreneurial development etc. of the beneficiaries at the prescribed rates) during the last 3 years *i.e.* 1996-97, 1997-98 and 1998-99 under the Prime Minister's Rozgar Yojana is enclosed. (*See* below). The Prime Minister's Rozgar Yojana is implemented in both urban as well as rural areas. Separate funds for urban and rural areas are not released. No subsidies are released to the States.

- (b) Banks contribute eighty per cent of the project cost as loan. The Reserve Bank of India has reported that the banks branches ensure that the money provided to the unemployed youth is being properly used by conducting periodical post disbursement visits to the place of activity of the borrower, that assets are acquired/maintained properly. In case of misutilisation of the loan amount sanctioned, banks initiate legal steps for recovery-of dues.
- (c) As per reports received, of the total cases disbursed loan, units were set up in 92.59% cases in 1997-98 (133019 units were set up out of 143659 cases disbursed loan) and in 91.79% cases in 1998-99 (106080 units were set up out of 115565 cases disbursed loan).
