Import Duty was increased to 60% with effect from 9.2.2000 to discourage imports of sugar which were having an adverse effect on the domestic industry and keeping in view the comfortable domestic production and stocks and the falling trend in the international prices of sugar. It will also enable the sugar mills to pay the cane price dues of farmers in time.
