(MoU) was signed between India and USA in 1994. As per clause 4 and 5(b) of the MoU, India is to notify the binding at reduced levels for certain textile products indicated in the MoU. These textile products include fibres, yarns, industrial fabrics and home furnishings, besides others.

THE MINISTER OF STATE IN THE MINISTRY OF TEXTILES (SHRI GINGEE N. RAMACHANDRAN): (a) and (b) No, Sir, 8 subsidiaries of NTC were refered to and declared sick during 1993-94. BIC and its Cotton Subsidiaries also declared such during 1992-93. A statement giving State-wise number of mills enclosed. (See below)

(c) to (e) Except Ajudhia Textiles Mill, Azadpur which was closed as per the Supreme Court's order on Polluting Industries after paying compensation to the workers as per the Court order, no other mill of NTC has been closed and as such no worker has been rendered jobless.
