market for assured quality and health standards and also effecting necessary technological improvement of processing units. Under the Scheme, financial assistance in the form of soft loan and grant is provided to both egg and poultry processing industries. The Government is also monitoring the quality aspect of egg products meant for export under the Export (Quality Control & Inspection) Act, 1963 through Export Inspection council of india, for developing the confidence of the foreign buyers in respect of quality of Indian egg products.

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI SBPBK SATYANARAYANA RAO): (a) to (c) It is primarily the responsibility of the State Government concerned to undertake necessary relief measures in the wake of natural calamities. The Government of India supplements the efforts of the State Government by providing resources in accordance with the recommendations of the Finance Commissions appointed from time to time. No report in this regard has been received from the Government of Orissa.

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI HUKUMDEO NARAYAN YADAV): (a) Approximately 3 kgs. of pearls are produced every year through culture activities at Mandapam and Tuticorin.
