(a) and (d) Under the ITEC Programme, when a requisition is received from a foreign government for nomination of an expert, the database is accessed for drawing the names of experts meeting the requirements, if available, and if not, the vacancy is circulated inviting applications/nominations of eligible experts. Experts meeting the requirements are considered for nominations. The database on experts maintained is based on the experience profile of the experts only. Therefor, information on the number of persons belonging to SCs/STs among those nominated is not available.

As for Bilateral Assignments, in respect of Maldives, out of a total of 27 experts, 2 were SC/ST (7.4%). Of the 220 experts sent to Bhutan, 10 were SC/ST (4.5%). In respect of experts sent to Nepal, the SC/ST aspect is not reflected in the application forms filled in by the candidates. Hence, this information is not available.

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI AJIT KUMAR PANJA): (a) and (b) Yes Sir. The representations were forwarded by the Prime Minister's Office to the Ministry of Social Justic and Empowerment to be followed up by them with the other Ministries/ Departments of the Government of India for implementation.

(c) The total number of Indian Missions/Posts functioning abroad on 1.1.1996 was 152 and on 1.1.2000 was 157. The number of persons belonging to the SC/ST category working against the posts of Ambassadors/ High commissioners/Consul Generals on 1.1.1996 was 25 [SC-18; ST-7] and on 1.1.2000 was 22 [SC-13; ST-9]

- (b) and (c) The overall guidelines for all Ministries/Departments of the Government of India with regard to filling up of posts for SC/ST/OBC candidates are formulated by the Department of Personnel and Training. The Ministry of External Affairs strictly adheres to these guidelines.
- (a) and (e) The information in respect of the number of vacancies for SCs/STs in the Ministry of External Affairs as on 1st January 1993 is placed below in a tabulated statement (See below). To fill up these vacancies, appropriate indents have been placed with Staff Selection Commission/Union Public Service Commission. The information in respect of the Statutory/autonomous and attached offices of the Ministry is being collected and shall be laid on the table of the House.
