THE MINISTER OF STATE IN THE MINISTRY AGRICULTURE (SHRI SBPBK SATYANARAYANA RAO): (a) and (c) The Directorate of Marketing and Inspection (DMI), and attached office of this Ministry, has been taking various steps for bringing about an integrated development of marketing of agricultural produce in- the country. The main activities of DMI relate to promotion of standardisation and grading of agricultural produce, marketing research, surveys and planning, and provision of training facilities for employees of State Governments on regulation and management of Agricultural Produce Markets. Recently, a Central Sector Scheme for Agricultural Marketing Information Network has been approved for bringing about improvements in the present market information system by establishing a nation-wide information network for speedy collection and dissemination of market information/data for their efficient and timely utilisation. Under this scheme, all important Agricultural Produce Markets and State Agricultural Marketing Boards/ Department all over the country, including those in the State of Uttar Pradesh, will be linked up through computer network.

  - (1) Subsidy 11790 per cent of the cost subject of a ceiling of Rs. 25000 per hectare for installation of sprinkler irrigation system and drip irrigation system under various crop oriented production programmes.
  - (2) Assistance to the extent of 50 per cent of the cost of the improved farm implements or Rs. 1500 per equipment which ever is less under the Oilseed Production Programme.
  - (3) Subsidy of 50 per cent on premium under the Rashtriya Krishi Bima Yojana.
