(b) if so, the number of teachers, readers and professors of SC/ST categories recruited in its teaching departments and colleges during the last five years, department-wise and college-wise?

(b) As per the information provided by Delhi University, 9 lecturers have

been recruited in Delhi University during the last 5 years under SC/ST categories. The Department-wise break-up is as under:
