THE MINISTER OF HEAVY INDUSTRIES AND PUBLIC ENTERPRISES (SHRI MANOHAR JOSHI): (a) and (b) The total investment in Central Public Sector Undertakings as on 31.3.99 was Rs. 230140 crores, out of which Rs. 96717 crores was by the Central Government.

- (c) The average net profit earned by the Central Public Sector Undertakings during the last five years is about Rs. 10780 crores per annum.
  - (d) As on 31.3.99, about 19 lakh persons were employed in these PSUs

## Trade between India, China and Japan

- 1824. SHRI ANANTA SETHI: Will the Minister of COMMERCE AND INDUSTRY be pleased to state:
  - (a) whether there is a vast scope for the expansion of trade between India, China and Japan;
    - (b) if so, the steps taken in this regard during the last three years;
    - (c) the areas identified for the expansion of trade with these countries;
- (d) the steps taken to boost Indo-China and Indo-Japan trade in Ninth Plan in coming years; and
  - (e) the details thereof?

THE MINISTER OF COMMERCE AND INDUSTRY (SHRI MURASOLI MARAN): (a) to (e) There is scope for expansion of trade between India and both China & Japan. This scope is dependant on the commodities needed by either sides and the ability to offer the same at competitive prices. The last round, that was the 14th Round of Indo-Japan Trade Talks was held in New Delhi in February, 1999 and the Indian delegation was led by Commerce Secretary. The various areas identified during the 14th Round of Indo-Japan Trade Talks included export of jewellery, fruits, flowers, software development services, Japanese investment, etc. The Japanese side evinced interest in infrastructure development in India, simplification of custom procedures, concern over anti dumping duties, application of safeguards provisions, imposition of special import duty, etc.

The Sixth Session of Indo-China Joint Group on Economic Relation and Trade, Science and Technology has since taken place in Beijing on February
